

## What is an Executive Order?

The term Executive Order has been used a lot over the last year in our Village. We thought it would be helpful for our Administrator, Amee Hughey, to explain what an Executive Order is.

ElderHealth & Living was placed under Executive Order ("EO") most recently on 4/5/21 due to our campus being exposed to COVID when a staff member and a resident both tested positive for COVID. When an EO is placed on a facility, it alters the existing regulations put into place by the Oregon Department of Human Services (ODHS) around visitations.

The EO will be lifted after two consecutive weeks of all negative COVID test results for all residents and staff, and with approval from ODHS. Once lifted, EHL can go back to the testing requirements and visitation rules set forth by ODHS and governed by Lane County's risk level. *Please see the next page for more details on the EO*.

We understand how disappointing and frustrating this situation can be for our families. Please be assured we are doing all in our power to resume in-person visitations, as we understand how important it is for the residents and their loved ones. However, it is our understanding if Lane County moves in to the Extreme Risk Level, visitations will continue to be restricted. #### **EXECUTIVE ORDER MANDATES**

Pursuant to the Governor's Executive Order NO. 20-03, now extended through May 2, 2021, Declaration of Emergency Due to Coronavirus (COVID-19) Outbreak in Oregon, the Aging and People with Disabilities Executive Letter sent to all Residential Care Facilities on March 10, 2020. DHS now orders that Respondent is subject to the mandates set forth below:

 RESTRICTION OF VISITATION: Visitors shall be restricted from entering the facility to prevent further spread of the virus and to ensure the health and safety of all residents and the broader community.
